

CONFERENCE LAUNCH

On the initiative of the Faculty of Organizational Sciences, University of Belgrade, partnership with the Faculty of Economics and the Faculty of Law (also members of the University of Belgrade) are created to promote excellence in financial decision-making. As a result, the organization of the high end financial management conference is proposed. The aim of the First International Contemporary Financial Management Conference (CFMC|2022) is to bring together academics and practitioners who are interested in presenting new cutting edge research and discussing existing issues in financial management.

The first meeting of the program committee was held on 18th of March, 2022 which denoted the official start of the founding activities. The Conference is going to be held biannually, and one of the three founding faculties will be the official organizer of the event. The Faculty of Organizational Sciences, University of Belgrade, as initiator of this collaboration will be the organizer of the First International Contemporary Financial Management Conference CFMC 2022.

The initiator sets the broad topic, date, and venue of the Conference. Furthermore, program and organizing committee members were announced at the meeting. In order to truly bring an excellence in all aspects of the conference organization and not just into the financial decision-making, topic list and list of program committee members is not definite. More quality members who can help in pushing the boundaries' of financial management competencies are more than welcome to join the team. So far, organizing committee consists of professors and teaching assistants' from the Faculty of the Organizational Sciences, University of Belgrade. The next step in founding activities is to appoint members to organizing committee of the Faculty of Economics and the Faculty of Law. The CFMC 2022 website is created, running and being updated with the advancements of the organizing activities.

Initial suggestion for Conference fee is set and can be amended upon the founders' decision, and depending on the global economic outlook. Important dates for the CFMC 2022 are:

Early Bird Registration: JUNE 15, 2022

Abstracts/Full Paper Submission: OCTOBER 10, 2022 Notification of Acceptance: OCTOBER 31, 2022

Final Paper: NOVEMBER 20, 2022

Conference Dates: DECEMBER 07-10, 2022

A final list of the keynote speakers is not finalized yet. The idea of the CFMC|2022 is to include esteemed experts from the finance and accounting field who are recognized globally, and for the moment we are waiting for their consent.

- **09.12.2022** Program sessions to be held at the Faculty of Economics and the Faculty of Law;
- **10.12.2022** Program sessions and closing ceremony to be held at the Faculty of Organizational Sciences.

The workshops are aimed at the Master and PhD students. So far, the agenda for the workshop "Effectiveness of cybersecurity audit" moderated by PhD Marko Cular is fully prepared. Preparations for the two more workshops, with the themes related to the Fintech and Fraud & Financial forensics are underway.

We are currently planning for a fully in-person conference. Depending on the global pandemic situation, the conference can be held virtually or on a blended basis.
